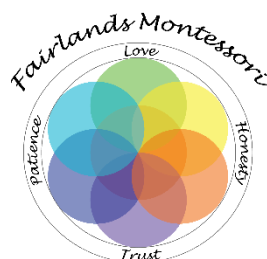
Conditions of Admission to Fairlands Montessori

1. The Applicant/s and the Student will be bound by the rules, regulations, policies, and procedures of Fairlands Montessori Pre-Primary as laid down by the owners and the heads of the school. The Applicant/s confirm that by signing this enrolment contract, that he / she / they will have read, and discussed the Fairlands Montessori Pre-Primary Parents Handbook.
2. The Applicant/s hereby acknowledge and confirm that they are personally liable for all terms and conditions herein and to be effected in terms hereof, including but not limited to: Fairlands Montessori Pre-Primary Parents Handbook
3. The Applicant/s and the Students undertake at all times to uphold the good name and reputation of Fairlands Montessori Pre-Primary.
4. The Applicant/s accept that personal possessions of the Pupil are not covered in any risk insurance by Fairlands Montessori Pre-Primary and that the Applicant/s are responsible for supplying adequate cover for the Pupil's personal possessions.
5. The Applicant/s accepts liability for any loss or damage suffered by Fairlands Montessori Pre- Primary arising from any conduct of the pupil, howsoever caused.
6. The Applicant/s understand that Fairlands Montessori Pre-Primary will constantly endeavour to take such steps as may be reasonably required in the circumstances to do what it can to ensure an environment free from harm and / or loss, taking into account what can be reasonably foreseen and provided for in the circumstances.
7. The Applicant/s hereby indemnify and hold blameless Fairlands Montessori Pre-Primary, its shareholders, directors and employees against any loss, damage or injury which may be sustained from whatever cause excluding gross negligence, whether on Fairlands Montessori Pre-Primary property or in any extra mural activity that the student may participate.
8. The Applicant/s understands that the information contained in the enrolment contract constitutes a material representation relevant to the acceptance of the enrolment of the Applicant's/s' child as a Pupil and the Applicant/s warrant that all information contained in the enrolment contract is true, complete and accurate.
9. The Applicant/s further agree that any change in information supplied in this agreement including but not limited to the Applicant/s marital status, residential status or employment status does not alleviate the agreement made herein, and any such change will be reported in writing to Fairlands Montessori Pre-Primary.
10. Any relaxation or deviation from the terms of this agreement, which may have arisen in the past or may arise in the future, shall not be deemed to be a waiver of Fairlands Montessori Pre-Primary rights to enforce strict compliance with these conditions without further notice.

11. This agreement shall be deemed to be concluded upon the enrolment of the Pupil by Fairlands Montessori Pre-Primary, and on the payment of the registration and admission fee stipulated by Fairlands Montessori Pre-Primary and shall constitute the whole agreement between the parties and no amendment, alteration, addition, variation, representation or warranties, whether expressed or implied, will be of any force or effect unless reduced to writing and signed by both parties.
12. All legal correspondence between the Applicant/s and Fairlands Montessori Pre-Primary sent by Fairlands Montessori Pre-Primary shall be delivered by hand, either directly to the Applicant/s or via the Pupil or sent by pre-paid registered post. The correspondence shall be deemed to have been received on the date of delivery or on the 5th business day after posting. In regard to all correspondence by the Applicant/s to Fairlands Montessori Pre-Primary, the onus of proof of delivery shall rest on the Applicant/s.
13. The Applicant/s acknowledge that Fairlands Montessori Pre-Primary shall be entitled to recover all legal costs incurred by it, in order to enforce its rights under this agreement, including but not limited to attorney and own client fees and collection and tracing charges.
14. The Applicant/s understand that by signing this form he /she / they consent to Fairlands Montessori Pre-Primary conducting whatever enquiries may be considered necessary to verify any information given in this application, including confirming his / her / their credit rating with a national Credit Bureau and contact with previous schools of the Pupil.
15. Fairlands Montessori is affiliated to TPN Credit Bureau, a registered credit bureau, all account payment profiles, patterns and behaviour is recorded monthly with the credit bureau for the purposes as per the National Credit Act
16. The Applicant/s consents to and authorises Fairlands Montessori, the service provider, to contact, request and obtain information at any time from any supplier/school, service or credit provider (or potential credit provider) or registered credit bureau in order to assess the behaviour, profile, payment patterns, indebtedness, whereabouts, and creditworthiness of the Applicant/s and provide information about the behaviour, profile, payment patterns, indebtedness, whereabouts, and creditworthiness of the Applicant/s to any registered credit bureau or to any supplier/school, service or credit provider (or potential credit provider) seeking a trade reference regarding the Applicant/s dealings with the supplier/school, service and/or credit provider.
17. On termination of this agreement for any reason whatsoever, the Applicant/s undertake to immediately withdraw the Pupil from Fairlands Montessori Pre-Primary and to make satisfactory arrangements for the Pupil's attendance at any alternative school.
18. Fairlands Montessori Pre-Primary shall be entitled to cancel this agreement by giving the Applicant/s 1 (one) months written notice to this effect.

Payment of Fees

1. School fees in the annual fee structure from time to time, are payable monthly in advance, by the 1st of the month.
2. Interest shall accrue on all fees and disbursement not paid by the due date at a rate to be determined by the Board from time to time, which rate shall not exceed the maximum rate prescribed by law. The said interest shall be calculated and compounded monthly in arrears from due date to date of payment, both days inclusive.
3. The Applicant/s will be liable for Fairlands Montessori Pre-Primary customary charges and necessary disbursements incurred in the administration relating to the late or non-payment of the said fees.
4. The Applicant/s consent to the jurisdiction of the Magistrate's Court in respect of any action to be instituted by Fairlands Montessori Pre-Primary.
5. In the event that Fairlands Montessori Pre-Primary is obliged to institute legal action for outstanding school fees and related expenses due by the Applicant/s then, and in that event, the Applicant/s shall be liable to Fairlands Montessori Pre-Primary for all expenses incurred in collecting any amount owing by the Applicant/s, which expenses shall include all legal charges on the scale as between attorney and- own-client, collection commission and tracing fees.
6. Without limiting or detracting from Fairlands Montessori Pre-Primary rights to enforce payment of any and all monies not paid on or before due date to Fairlands Montessori Pre-Primary by the Applicant/s, Fairlands Montessori Pre-Primary may, in its sole discretion:
 - (i) Suspend the Pupil from attending the classes until such date as all fees and monies have been paid in full.
Withhold the release of reports, and transfer cards until such date as all fees and monies have been paid in full.
7. School fees are subject to an annual increase.
8. All incidental expenses incurred during the course of the term shall be due and payable as and when charged and upon presentation of the statement of account.
9. The Applicant/s agree to the upfront payment of the NON REFUNDABLE registration and administration fee as per the current fee structure, prior to admission and acceptance of the Pupil to Fairlands Montessori Pre-Primary.
10. The Applicant/s acknowledge that the inability of the Pupil to attend school or the absence of the Pupil from the school does not relieve the obligation to pay school fees.
11. One (1) calendar months' notice must be given in writing of a Pupil's intention to leave Fairlands Montessori Pre-Primary or one (1) months' notice will be billed and payable in lieu of notice;
12. The Applicant/s accept joint and several liability for the due and punctual payment of such school fees or other amounts which may become due and payable to Fairlands Montessori Pre-Primary or in respect of attendance or participation by the Pupil in any extramural or school related activities.

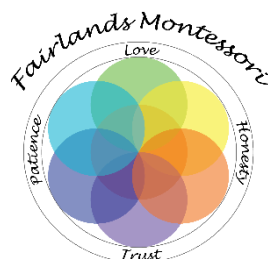

Holiday School fees:

- For children with "excluding holiday school fees" a flat rate of R150 will be charged per child per day.

School fees Terms and Conditions

- There will be a yearly fee increase in January of each year.
- All monthly fees are payable by the 2nd day of each month, including during the holiday times. PLEASE NOTE that a 10% levy will be added on to late fees.
- Fees not received by the 7th working day of the month will result of the child/ren being denied access to the school until the full outstanding amount has been settled.
- Late collection fees are as follows: R50 for the FIRST 5 MINUTES thereafter will be R20 PER MINUTE!!!
- To qualify for the annual **10% upfront discount**, fees need to be paid in full by the 15th of January 2022- this being limited to the **first enrolled child-** PLEASE NOTE that the annual fee discount will not apply to any sibling's upfront payment, sibling discount shown below:
- We offer a sibling discount of 7.5% for the first sibling, 5% for the second sibling, 2.5% per additional siblings thereafter- this in affect if school fees are paid in full by the 15th of January 2022 or 11 equal instalments.

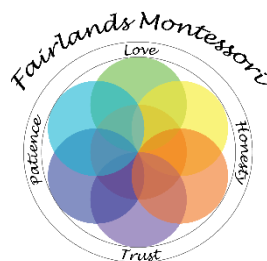

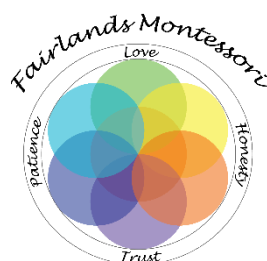

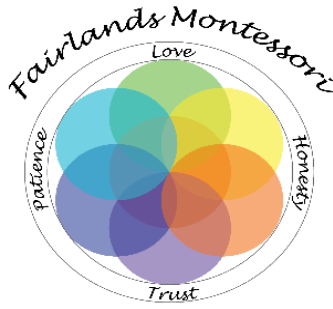
